



#### Asia Economic Outlook 2024

14 MARCH 2024

As part of the Thursdays with the SGC webinar series, the SGC was delighted to welcome Dr Charlie Lay (Left image; on left), Director and Senior Economist at Commerzbank, as a speaker on the topic of the Asian Economic Outlook 2024. Based on the question, "Is the global economy resilient and unstoppable?", his presentation focussed on the economic developments of the US and China as well as the global spillover effect in Asia; particularly the ASEAN region.

Dr Lay emphasised diversification as one of the most impactful economic trends. Especially in the post-pandemic period and the current geopolitical conflicts, the global diversification of supply chains shows the importance of ASEAN as an emerging region alongside and as a counterpart to China. Striving for independency, diversifying supply chains, and increasing productivity are the objectives of the current economic situation.



### E-Invoicing in Europe and Southeast Asia

Overall, governments across the globe are transitioning towards E-Invoicing as it streamlines processes for both taxpayers and authorities, enhances transparency and security.

#### Risk of Double Taxation for German Expats



The SGC was delighted to host its webinar on the topic 'Risk of Double Taxation for German Expatriates' with more than 40 participants in attendance! Our speakers, Mr Jens Goldstein from EY GmbH & Co. KG and Mr Philipp Borchert from EY Corporate Advisors provided an in-depth analysis of a circular issued by the Federal German Ministry of Finance in December 2023. The circular has brought additional uncertainty for both German expatriates and their employers.

The speakers elaborated on the shifting criteria for determining tax residency, and they also discussed the more complex criteria surrounding the definition of an economic employer, which could lead to increased documentation requirements.

The webinar concluded with a call to action for German expatriates working abroad to closely review their tax situations with their tax advisors to mitigate potential risks, including preparing for appeals or enhancing documentation processes.



#### Mastering Transfer Pricing in Singapore

The SGC was delighted to welcome Ms Priya Selvanathan, Head of International Tax & Transfer Pricing ASEAN at Roedl & Partner Singapore, to speak at our webinar on 'Mastering Transfer Pricing in Singapore'. Ms Selvanathan gave an overview on the latest developments of Singapore's transfer pricing regulations and documentation requirements to ensure compliance and fair business transactions.

As the operating environment becomes increasingly complex, it is crucial for international companies to stay informed of the changes and their implications. The webinar allowed our participants to gain first-hand insights into the best strategies for a robust transfer pricing strategy, and common pitfalls to look out for under the new regulations. Ms Selvanathan also elaborated on preparing and maintaining comprehensive transfer pricing documentation keeping in mind the guidelines from the Inland Revenue Authority of Singapore (IRAS).

#### 'Are You Confident of Your Financial Future?'



An important financial planning tool introduced to our members for financial security was the effective use of Exchange Traded Funds (ETFs), a passive fund that trades at the stock exchange and is highly diversified. In the discussion with chamber members, Mrs Sturm highlighted common pitfalls in retirement planning such as asset clustering and underestimating the effects of inflation rates on our personal finances.

#### 'Life in a Drop – Addressing Blood Plasma Uniqueness and Supply Challenges'

It was a lively discussion at this cross-chamber committee event on the topic 'Life in a Drop – Addressing Blood Plasma Uniqueness and Supply Challenges'. The event was moderated by Mr Maximilian Englisch (WALDNER Group & SGC Healthcare Committee Co-chairperson). Mr Bruce Wee Diong Lim (IPOPI), Ms Svenja Barckhausen (Blood Plasma Strategy Expert) and Mr Phillip Hammer-Purgstall (INOSOLVE Group) were invited as panellists.

The event highlighted blood plasma's essential role in healthcare, as IgG immunoglobulins are vital for treating rare diseases and immune deficiencies. Global efforts to boost plasma donations are necessary to secure drug supply. Varying GMP standards worldwide limit plasma fractionation, impacting availability. Asia relies on plasma-derived medicine imports, with the USA as the primary exporter and a key supplier.

The SGC successfully organised eight meetings during Dataport's Pre-Delegation trip across the week of 15 - 19 April. The delegates met the Ministry of Digital Development and Information, German Embassy Singapore, Infocomm Media Development Authority (IMDA), Smart Nation Digital Government Office, GovTech, Lufthansa Innovation Hub, ST Engineering Singapore and Mastercard. Dataport had fruitful exchanges with the agencies and companies, experiencing and learning Singapore's strategies towards digitalisation.

The final delegation from 8-13 September was led by State Secretary Mr Jan Poerksen, Head of Senate Chancellery of Free and Hanseatic City of Hamburg. We kick-started the delegation trip with a comprehensive country briefing

by the German Embassy and the SGC. Thereafter, Dezan Shira & Associates gave further insights into Singapore's governance and administrative structure, and digitalisation strategies and the function of the Smart Nation and Digital Government Office.

During a networking dinner, Dataport invited meeting partners to reignite ideas, deepen business relations and explore further collaborations. Later in the week, the delegation visited the URA Gallery to explore Singapore's smart city initiatives and learn more about Singapore's transformation from the early 1960s to present. Afterwards, the delegation visited the Punggol Digital District hosted by JTC to learn more about future developments for Singapore.

Mr Schulze was welcomed by Grace Fu, Minister for Sustainability and the Environment and Ministerin-charge of Trade Relations at the Ministry of Trade and Industry, Singapore, where the parties discussed bilateral investment opportunities and possibilities on strengthening economic cooperation in the semiconductor industry and other technologies.

Also part of the programme was the SGC Dialogue where both Mr Schulze and Dr Robert Franke, Managing Director of the Investment and Marketing Corporation Saxony-Anhalt, presented on Saxony-Anhalt as a dynamic hub for growth and innovation.





#### Visit by the First Mayor of **Hamburg to Singapore**

**25-28 SEPTEMBER** 2024

Dr Peter Tschentscher, First Mayor of Hamburg, visited Singapore accompanied by a distinguished delegation of political, business, and academic leaders from the Hanseatic City. The SGC had the honour of supporting this delegation by providing a comprehensive country briefing on Singapore's political and economic landscape, in collaboration with the German Embassy Singapore and Germany Trade & Invest (GTAI).

The reception brought together key stakeholders from both cities and further strengthened the strong ties between Hamburg and Singapore, paving the way for promising new opportunities. Important collaboration agreements were reached in key areas such as maritime decarbonisation, digitalisation, cybersecurity, and the promotion of innovation and internationalisation in transportation, logistics, and academic partnerships.

We look forward to continuing our close cooperation with our valued partners to further deepen bilateral relations and foster new initiatives between Singapore and Hamburg.

#### **Business Mission on Energy Efficiency (Hydrogen) to Germany**

#### 20-25 OCTOBER 2024

The SGC led nine Singaporean companies and institutions to Hamburg and North-Rhine Westphalia, exploring Germany's (green) hydrogen innovations along the value chain. Funded by the Federal Ministry for Economic Affairs and Climate Action (BMWK) under the German Energy Solutions Initiative, the delegation attended the Hydrogen Technology Expo Europe, and also engaged with key stakeholders on advancements and challenges in the hydrogen sector.

The trip showcased practical hydrogen applications, including 2G Energy AG's combined heat and power systems (CHP), a hydrogen refueling station at the Hydrogen Application Centre in Herten, and Klimakommune Saerbeck, which demonstrated sustainable energy and hydrogen production through wind and solar power at a former ammunition depot. Mabanaft shared their mission to build a clean hydrogen supply chain and insights into its innovative project New Energy Gate.

Meanwhile, Quest One highlighted its innovative electrolyzer production and electrolysis stacks, aiming to reduce 1% of global greenhouse gas emissions by 2050. Insights into salt caverns as storage options especially in the north of Germany, were given by Storengy Deutschland. At Chemiepark Marl, Evonik explained the role of hydrogen in chemical production alongside an impressive overview of the site, which is three times the size of Monaco.

A roundtable hosted by NRW.Global Business allowed for insightful discussions on current industry developments in Germany and Singapore.







#### **Berlin Goes Singapore:** Fintech, AI, Blockchain,

The SGC was delighted to host a delegation from Berlin on the topic of FinTech, AI and Blockchain funded by Germany Trade & Invest and in collaboration with Berlin Partner für Wirtschaft und Technologie GmbH. 





## How Can European Export Agencies Support Businesses in Vietnam?

**30 SEPTEMBER** 2024

Atradius Dutch State Business, Euler Hermes and ERV Swiss Export Risk Insurance organised a joint event in Ho Chi Minh City. During a very insightful afternoon, the three Export Credit Agencies (ECAs) presented how they can support European companies exporting to Vietnam. But it was even more important to show how Vietnamese companies and projects can benefit from buying Dutch, German or Swiss suppliers. And Vietnamese buyers can benefit from advantages such as longer payment terms, lower interest rates and total financing costs.

In front of an audience of approximately 120 visitors, Thomas Baum held the opening speech, representatives of the embassies gave their view on the opportunities to work together. Mackenzie Masaki provided an overview of ECA financing and gave a short introduction how export

credit agencies work, and in a panel discussion Alexandra Lutz, Schmidberger Klaus and Stephan Naber shared their views on the opportunities for international trade.

Two interesting case studies, from GE and ING on a combined cycle power plant, and from GELEX Group, Enercon and LBBW on a wind farm, gave a clear picture on the opportunities advantages and possibilities there are for European and Vietnamese companies to work together.

## **VDMA Southeast Asia Summit in Singapore**

**29 NOVEMBER** 2024

At the VDMA Southeast Asia Summit in Singapore last November, the main topic was on the future positioning of European engineering in the Southeast Asian region.

Together with GTAI Hub ASEAN, GTAI Vietnam and Alexandra Lutz from the SGC's Competence Centre for German Export Finance, the focus was on the current economic landscape and prospects in ASEAN in general and Vietnam in particular.

## Competence Centre for Trade Policy (Asia/ASEAN)

The Competence Centre for Trade Policy (Asia/ASEAN) at the SGC provides trade policy expertise for the Asia-Pacific region since May 2017. The Competence Centre is tasked by the German Association of Chamber of Commerce and Industry (DIHK) and the Federal Ministry for Economic Affairs and Energy (BMWK) to monitor and provide public information about trade policy developments and assist companies to leverage FTAs. To do so, the Competence Centre organises roadshows, outreach events and webinars on trade policy and compiles newsletters and publications.

The competence centre also provides corporate advisory services for companies that seek to build a

strategy on trade policy and leverage specific trade agreements. These services include building tariff optimisation strategies and FTA mappings, trade policy risk assessments (EU GSP compliance) and inhouse FTA trainings.

### Webinar: Results of the SGC Business Sentiment Survey

15 MAY 2024

The SGC hosted a webinar to present the findings of its 2024 Business Sentiment Survey, presented by Kai Neuber, Head of Centre of Competence for Trade Policy (Asia/ASEAN) at the SGC. The survey captured insights from 73 member companies spanning diverse sectors, with a strong representation from micro, small, and medium enterprises.



The webinar highlighted cautious optimism among members regarding the business outlook for 2024, though positivity was tempered compared to the previous year.

ASEAN was identified as the region with the highest growth potential, followed by India, while confidence in China's growth prospects continued to decline. Staffing plans reflected this sentiment, with most companies opting to maintain current levels, while a smaller proportion anticipated expansion.

A significant focus of the discussion was on new regulatory frameworks, including the German Corporate Due Diligence Obligations in Supply Chains Act (LkSG) and the EU's Carbon Border Adjustment Mechanism (CBAM). While many member companies were not directly impacted, a "trickle-down effect" was evident, with smaller firms indirectly affected through their business relationships with larger enterprises. Key challenges cited included supply chain complexity, insufficient regulatory knowledge among suppliers, and increased administrative burdens.

The webinar highlighted the SGC's commitment to helping members navigate emerging challenges and understand the evolving business and regulatory landscape in Singapore and ASEAN.

### VDMA Webinar: Southeast Asia for Intermediates – Singapore

#### **17 OCTOBER** 2024

Last October, the SGC participated in a webinar organised by the VDMA titled 'South East Asia for Intermediates: Singapore'. The event brought together industry leaders to discuss opportunities and strategies for companies operating in the region.

Representing the SGC, Kai Neuber delivered a presentation on the effective utilisation of Free Trade Agreements (FTAs) in Southeast Asia. The session focused on guiding companies to optimise tariff payments by leveraging various regional FTAs based on their sourcing strategies. The presentation emphasised practical approaches to navigate complex trade frameworks and maximise cost efficiencies.



Other speakers included representatives from the Singapore Economic Development Board (EDB), Enterprise Singapore, and SICK, who shared valuable insights on Singapore's role as a regional hub and strategies for business success in the ASEAN market. This collaborative effort highlighted the dynamic opportunities available to companies operating in Southeast Asia and underscored the importance of strategic partnerships.



### Lessons in Excellence: Germany and Singapore's Shared Path for Global Competitiveness

1 AUGUST 2024

In 2024, the SGC initiated the preparation of a comprehensive report to commemorate two decades of collaboration between Singapore and Germany. The report, focused on six critical economic location factors, highlighted areas where Singapore and Germany excel and opportunities for mutual learning.

Key topics included digitalisation, reducing bureaucracy, and foreign direct investment for Singapore, while Germany's focus areas were smart manufacturing, energy efficiency, and vocational training. Insights were drawn from expert interviews across various sectors and a survey of SGC member companies, which ranked priorities for fostering economic growth and global competitiveness over the next decade.

The final report was unveiled during a special members' event in mid-January 2025, reflecting on the longstanding partnership and shared commitment to innovation and sustainability between Singapore and Germany.

## Finance & **Corporate Affairs**

The Finance department at the SGC deals with the financial, accounting and corporate affairs activities of the chamber. These include financial reporting and compliance submission, payroll and staff benefits and corporate affair management such as compliance and regulatory issues in the legal area, internal communications with human resources, external communications with stakeholders and annual reporting. The department also covers office administration matters such as office and director's insurance, risk management assessment, contract management, cost analysis and other essential administrative affairs.

## **Finance & Corporate Affairs**

### **Finance Reporting**

SGC's financial cycle follows the calendar year, from January to December. Annual budget planning occurs each August. We are required to report actual performance and forecasts quarterly to both DIHK and the Board. Year-end financial reports are audited in January and submitted to the relevant authorities one month after the Annual General Meeting (AGM). Additionally, the DIHK Annual Report will be submitted to DIHK/BMWK by March.

The budget for the fiscal year 2025 was submitted to DIHK in September 2024. Quarterly results and forecast meetings are held regularly to review the Chamber's financial status, considering various ongoing projects and services offered.

We conduct regular financial checks to ensure sound financial management, including monthly, quarterly, and annual financial reporting. Periodic financial statements are also submitted to DIHK for verification and guidance, ensuring effective checks and balances. Furthermore, we actively participate in finance meetings hosted by DIHK to stay informed about financial policies and updates.

In November 2024, the Chamber underwent an interim audit for the accounting period from January to September 2024. The final audit for the financial year ending 31 December 31 2024, is scheduled for February 2025.

The Agreed-Upon-Procedure for certifying the DIHK Annual Report for the year ending 31 December 2024, will be performed by the Chamber's auditors and submitted to DIHK in March 2025.

The Goods and Services Tax (GST) for Q4 2024 will be submitted to the Inland Revenue Authority of Singapore (IRAS) in January 2025. Employee employment income tax filings will be submitted to IRAS by February 2025, while the company's corporate tax return for the year 2024 will be filed by March 2025.

SGC has migrated its accounting and payroll systems (Sage 300 and Sage Easy Pay) to a cloud-based server for



enhanced security. Enhancements to Sage 300, such as the ability to generate bank files for upload, have been successfully implemented. The system is also being prepared for the implementation of E-Invoicing in 2025.

No significant changes have occurred in other accounting practices or regulations compared to previous reports.

### **Corporate Affairs**

To mitigate foreign exchange risk, the Chamber enters into forward foreign exchange contracts with a bank to lock in stable exchange rates for Euro funding.

The Chamber's insurance coverage was renewed in December 2024, including essential policies for Medical, Hospitalisation, Personal Accident, Travel, Office, and Association Liabilities. The insurers remain unchanged, with AIA, MSIG, and AIG providing coverage for Medical, Hospitalization, Personal Accident, Travel, and Office insurance, while Allianz Insurance covers Association Liabilities.

In line with good governance practices, the Chamber evaluates the appointment of auditors every three years. For the financial year 2025 and beyond, it is proposed that the Chamber engage Astute Practice Public Accounting Corporation as its auditors.

The Finance & Corporate Affairs section is responsible for a broad range of administrative duties, including overseeing office and director's insurance, conducting risk management assessments, ensuring compliance with office and financial reporting, performing cost coverage analyses, and handling various finance-related administrative tasks.
